## Key Terms & Conditions

1. These terms apply to the **Keypad 24-Hour 1 Year Discount**.
2. The tariff is available to new and existing Click Energy customers from 01 March 2021.
3. These terms are in addition to the Click Energy Standard Terms & Conditions for the supply of electricity to domestic customers. You can find the Click Energy General Terms & Conditions along with the Click Energy Customer Agreement Form (CAF) on our website **www.clickenergyni.com** or by calling **0800 107 0732**.
4. In the event of any conflict between these terms, the Click Energy General Term & Conditions and the CAF, these terms will apply.
5. Your fixed discount is set out in the table below. It will be applied from the date that Click Energy is registered as your supplier (new customer) or from the date of your new service agreement (existing customer) and will continue for a minimum period of one calendar year from that date. Details of the pence per unit/kWh rates for all our tariffs can be found on our website **www.clickenergyni.com**.

6. Your discount is as set out above and is calculated by reference to the Click Energy 'Keypad Standard 24-Hour' Tariff which may be amended from time to time during the Term of the Agreement, but this will not affect your Discount. This discount does not apply to the daily standing charge.
7. When the contract information is sent to you following your sign-up, you may cancel the tariff during the period of 14 calendar days (Cancellation Period) by writing to us via post, email or by contacting us on 0800 107 0732. If you cancel within this time, no termination charge will apply. However, if you leave the tariff after the cancellation period or the agreement is ended by you at any time before the end of the fixed term, you may be charged a termination charge of £30. This will be applied to your account.
8. After the expiration of the term, your Click Energy account may be switched to the Click Energy Standard electricity rates applicable at that time. You will receive at least 21 and no more than 42 days' written prior notice of any changes to your terms and conditions.
9. Click Energy reserves the right to amend the electricity unit rates or charges that apply to the tariff at any time during the term if there is a cost to Click Energy imposed by a governmental or statutory body (including a change in VAT), or as otherwise provided for in Click Energy General Terms & Conditions.
